### SECTION 4: First aid measures

#### 4.1 Description of first aid measures

- Local necrosis is evidenced by delayed onset of pain and tissue damage a few hours following injection.

#### 4.3 Indication of any immediate medical attention and special treatment needed

Because entry wounds are small and do not reflect the seriousness of the underlying damage, surgical exploration to determine the extent of involvement may be necessary. Prompt surgical decompression, debridement and evacuation of foreign material should be performed under general anaesthetics, and wide exploration is essential.
